 - a. Whitney Recreational Center Front Entrance Mural – Proposal is to create a mural on the front of the building. The artist(s) will work with children from the area that will inform the artist the direction of the mural. Proposed budget of \$47,000
 - b. Foster Care Public Art Campaign – Proposal is to create a traveling outdoor public art exhibit for 9 months that brings awareness to our communities need for foster parents. Proposed budget of \$125,000.
 - c. Von Tobel Part 2 – Proposal is to create a sculpture within the park. The artist(s) will work with children from the area that will inform the artist the direction of the sculpture. Proposal budget of \$68,000.
- VI. Assign Jury Members for existing calls - One board member will be assigned to represent the art committee on the jury for the Southwest Ridge Part 1 for public art. *(for possible action)*
