- c. Family Court House Courtyard Art – Proposal is to create a sculpture in the existing seating area and a mural on both flanking walls. Proposed budget of \$140,000.
  
6. Defund Sunset Litter Awareness – Due to the intensive administrative requirements of this project and the fact this project was appointed back in 2017. The funding for this project would be rolled over to existing projects that need additional funding; Sunset Signature Piece \$60,000, James Regional \$15,000, and 1 October \$75,000. *(for possible action)*
  
7. Adjust language to the Wetlands Monument Sign & Art – Due to the Wetlands Staff request to adjust project so that all funding goes toward artwork within the park and not to include the funding to a Monument Sign. Proposed rename of Wetlands Art. Budget is \$250,000.
  
8. Report by Clark County Parks and Recreation Public Art Office staff regarding monthly summary of current projects – All Districts *(not an action item)*.
