Clark County Parks and Recreation presents *LIFE IN DEATH: DIA DE LOS MUERTOS* in conjunction with a two-day festival featuring displays, an art exhibit, performances, craft sales and food vendors at Winchester Cultural Center and Park. The event explores cultural traditions related to the Mexican holiday of "El Día de los Muertos", or "Day of the Dead."

The Gallery hosts an exhibition of various artists celebrating the art of "Day of the Dead" and will feature the beauty that comes from such a unique event. Artists are advised to learn "Day of the Dead" traditions, which honor the dead, but also confront death itself, often with a humorous attitude. This celebration should not be confused with Halloween.

The show is juried by Estefania Rangel- a community organizer, activist, animal rescuer, Biological Science student at College of Southern Nevada and freelance cultural artist with Purépecha and Mexika (Aztec) roots. Estefania is also a co-founder of Fifth Sun Project, a community-empowering, grassroots organization focusing on raising awareness and funds for issues affecting their community and environment through art, culture, and activism. Providing a platform and safe space for local and non-local artists to express themselves is fundamental to the organization, as it leads to the development of relationships with community members who seek positive social change.
