**Jordan Bunker provided the monthly well report (attached) and provided updates on the LVVWD construction project. He gave apologies for Jim Prieur being unable to attend this meeting, but he will be coming to a future meeting to provide a hydrology report.**
  4. Receive a report from Metro regarding activity and statistics during the past month and other area crime concerns (for discussion only)  
**Officer Catricala stated that he had nothing specific to report. Evan shared a story about someone sleeping in their car in front of his house and frustration with the response and the non-emergency call process. Officer Catricala stated that the new Sheriff is making improvements to**

the phone system a priority. There was a brief discussion about the NDOT plans to add roundabouts along SR159.

5. Receive a report from BLM regarding current and upcoming projects, updates on Red Rock Legacy bike trail, information about Red Rock National Conservation Area, and other updates about Public Lands in the area (for discussion).

**Catrina Williams, Field Manager for Red Rock welcomed Brayden Gaard as the new Assistant Field Manager. Brayden shared that the loop had been closed Monday due to weather but was opened again on Tuesday. Additional Park Rangers have been hired and will be in the area doing programing and monitoring. The Legacy Trail continues to move forward and Phase 1 is 70% engineered. BLM Law Enforcement introduced themselves and shared that they are now fully staffed. Their dispatch number is 702-293-8998 and their email address is [SNDO\\_LawEnforcement@blm.gov](mailto:SNDO_LawEnforcement@blm.gov) Information was shared regarding emergency closure procedures of SR159 and the area that the officers cover.**

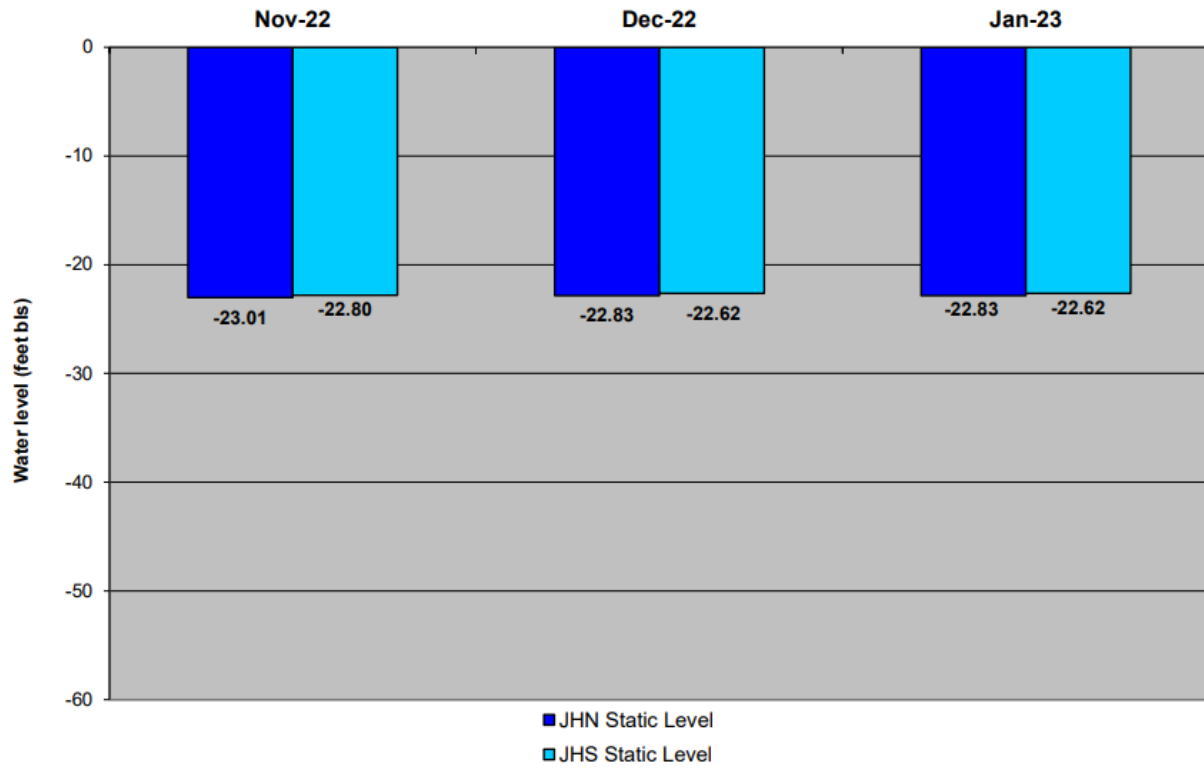
