







COPPER CHIEF: PAST PRODUCING SMALL MINES










COPPER CHIEF: 5 TARGET AREAS

- Indicates that Porphyry Cu-Au system may be present at a very shallow depth.



SANDY / IRONSIDE IS ONE OF THE FEW GOOD, UNTESTED, NEVER-DRILLED, GOLD - PGEs TARGETS IN THE UNITED STATES. FAULT ZONES WITH Au to +230 OZ/TON and PGEs TO 64 OZ/TON Pd and 15 opt Pd were mined at the BOSS MINE.



- COPPER CHIEF HAS A POTENTIAL SET-UP FOR LOW-COST BLOCK CAVE

NEVADA PROJECT HIGHLIGHTS Rimrock Gold Au-Ag, Nevada

•**RIMROCK GOLD**: 139 claims (2871 acres) lie along the Midas-Hollister Gold Trend in northern Nevada. Has Midas-style open pit / Underground *Dilation* and *Breccia* Midas-style gold-silver Targets in north and *Silver Hill* drill-indicated Carlinand Midas-style gold-silver targets in the southern part of the property.

• Midas Mine had drill-indicated 3,000,000 ounces of 1 oz/ton gold-12 oz/ton silver ore reserves. Initial ore reserves reported by Great Basin Gold for the Hollister Mine was at more than 1.3 ounce per ton gold and ~5 opt silver. Optioned to EXLA Resources (OTC: EXLA)




NEVADA PROJECT HIGHLIGHTS *Rimrock Gold Au-Ag Property, Nevada*

Rimrock Gold property, 139 claims immediately north of the high-grade Hollister Mine gold-silver mine of Hecla Mining, one of the world's highest grade gold mines. Hollister had 400,000 oz of gold mine production with drill-defined resource grades of over 1 oz/ton gold and substantial recovered silver. Rimrock Gold also lies north of Blackrock Silver's active Silver Cloud Au-Ag drilling project. OPTIONED TO EXLA Resources.


• The "Dilation" Midas-style gold-silver target area is in the northern part of the claims, just north of the Hollister Mine property of Hecla. This is a fault-controlled gold-silver target where a 100+ meter wide fault jog has opened up a Rhombochasm target where strong mercury mineralization was formed at the surface. This is a major underground Midas-style gold-silver target, and it could have untested bulk- tonnage potential. Midas/Hollister style gold Targets lie approximately 300-400m below the surface.

• The "Silver Hill" Midas- and Carlin-style Au-Ag targets are in the southern part of the Rimrock Gold claims area, adjoining the Hollister Mine property. Domed up Paleozoic upper plate rocks are exposed in an uplifted structural dome at Ivanhoe Creek, and shallow drilling in 2007 intersected gold, silver, and tungsten mineralization directly on Soloro's exciting main target, which is one of the only remaining structural dome targets on the Carlin Trend that has not been tested at depth by drilling. 







Figure 14-4: Unconformity Surface Colored by Elevation in Relation to Modeled Veins







This firm represents Jackson Dawson Communications, Inc. (the "Applicant") in the above referenced matter. The proposed project is located on 89.74 gross acres at the former Boss Mine property (APN: 201-27-000-002) (the "Property"). The Applicant is requesting a special use permit for a recreational facility to allow for an off-road driving adventure to experience the newest line of the Ford Bronco – the Raptor series. This Property location will complement the location previously approved for a recreational facility use permit located at the Kimball Scout Ranch (UC-21-0072).

Special Use Permit

The Property is currently is zoned Rural Open Land (R-U) and has a master plan designation of Open Lands (OL). The Applicant requests a special use permit to allow for off-road trail and course travel as part of a lifestyle experience being provided to new owners of the new Raptor line of Ford Bronco.
