- V. Informational Items
 - 1. Received a report from SVVFD; Chief Ken Smith reported the number of calls during the month of August. Chief Smith asked that if the Fire Department is closing roads for traffic accidents, please be so kind as to cooperate.
 - 2. Received a report from Metro; Sergeant Pickerel had nothing new to report and was available for questions. He addressed some concerns regarding noise complaints.
 - 3. Received a report from Sandy Valley School; Electra Smith announced that Friday Night Lights are back.

- 4. Received a report from Parks and Recreation; Shawna Robinson reported that the Community Center's water will be off from the 15th the 20th. This will also affect the Fire Department.
- 5. No report from Valley Electric.
- 6. Received a report from County Administration; Meggan Holzer, County Liaison reported Family Dollar is dealing with drainage issues on the site. The Gas Station has some equipment installed. NDOT construction on the onramp in Jean should be completed by mid September. Terrible Herbst sold the Casino and land where the Landing used to be. Plans are for a warehouse development with this new development NDOT has plans on adding another lane under the bridge. Meggan also announced the commissioner received some money and they are planning 4-5 events in Sandy Valley which include a Lighted Christmas Parade, Movie in the Park, and Missoula Theatre at Sandy Valley School. At the conclusion of Meggan's report, Chief Smith spoke on behalf of the Sandy Valley Fire Department, thanking Meggan for her help with the water suppression issue.

VI Planning and Zoning

1. DR-21-0420-SCHOOL BOARD OF TRUSTEES:

DESIGN REVIEW for a proposed expansion to an existing public school (elementary, junior high, and high school) with ancillary improvements on 24.0 acres in a P-F (Public Facility) Zone. Generally located on the north side of Pearl Avenue and the west and east sides of Hopi Street within the South County. JJ/nr/jo (For possible action) **10/6/21 BCC** Brandon McLaughlin, Project Architect of LGA Architecture and other associates went into detail of the plan for the expansion of the Sandy Valley School for a High School addition. Questions were answered and concerns were brought up by the public. The main concern was regarding the drainage of flood water. Residents south of Pearl had the most concerns.

 - 1. Denis Cederburg, Director of Clark County Public Works, discussed the status of road and trail projects in the area and responded to questions from the community. The widening of Columbia pass will be as much as granted, which was not much in some parts.
 - 2. Meggan explained the importance of Nominating a representative and possible alternate to serve on the Community Development Advisory Committee. Applications were available
 - 3. Meggan read previous requests for the budget and added new suggestions. A motion was made to accept the budget requests as read by Meggan.
