Adult Care Services

The Adult Care Services Unit provides the opportunity for all people living with a disability or struggling with a medical impairment to remain safely independent in their homes.

This unit also serves as a central point of contact for services and programs available to the aging population and/or adults with disabilities to ease the frustration that comes with accessing assistance.

Additional Services:

- Administers various grant funded programs relating to seniors and/or disabled adults
- Publication and distribution of the Royal Pages, a community resource directory for seniors
- Staff will assess each client for additional social service, rental/utility assistance programs as needed



Homemaker Home Health Aide (HHHA)

The HHHA Program assists individuals with household tasks they are unable to complete due to a medical condition so they can continue living independently in their homes.

Alternative Health Care Program (AHC)

The AHC Program aids the transition from hospital to home and assists the client in returning to living independently.

Services Include:

- Grocery shopping • Laundry
- Prescription pick up • Light housekeeping
- Personal care (bathing, dressing, and grooming)
- Meal preparation

Eligibility Requirements:

- Submission of completed referral form
- Resident of Clark County
- Not eligible for similar services through insurance or another program
- 18 years of age or older
- Disabled and/or have a medical need for services
- Submission of income and asset documentation to meet eligibility requirements.

Long Term Care (LTC)

The LTC Programs provide assistance to Clark County residents who are unable to accomplish daily essential tasks independently due to a medical condition.

Placement Options Include:

- Adult Day Care Facility
- Adult Group Care and Assisted Living Facilities
- Skilled Nursing Facilities



Eligibility Requirements:

- A completed long term care application
- Have a medical need for long term care
- Meet the criteria appropriate for the type of care requested
- Meet income and resource eligibility criteria
