

## Kinship Caregivers & Families Facing Immigration Issues Resource Guide

If you are undocumented & at risk of deportation, there are legal avenues for defense. For example, you may be eligible for deferred action, temporary protected status (TPS), or relief via family-based petitions. The organizations below can provide critical support for families facing immigration issues in Nevada, from legal assistance to explore all your options & family resources to help with healthcare & housing. Many of these services are free or offered on a sliding scale based on income.

### Legal Support Available:

**Las Vegas Legal Aid Center:** Offers free legal assistance to low-income individuals, including immigration-related support for issues such as family-based petitions, asylum, & deportation defense. They also provide resources for families dealing with child custody & family law.

**The Immigrant Home Foundation (IHF) or La Casa del Inmigrante:** provides comprehensive immigration legal services & empowering the community through education. IHF offers immigration legal services, including assistance with citizenship applications, permanent resident card renewals, work permit renewals, adjustment of status requests, & family petitions, as well as educational programs: Citizenship classes, adult literacy programs (e.g., free english reading/writing classes), & community workshops.

**Catholic Charities of Southern Nevada:** Offers a range of free services to immigrant families, including legal assistance with immigration petitions, refugee resettlement, social services, food assistance, & a variety of family services such as housing assistance.

**UNLV Immigration Clinic:** Provides free legal support & services for immigration cases for individuals meeting qualifications (e.g., unaccompanied children facing deportation, current ICE detained adult, UNLV students/employees). Immigration related legal services include assistance with DACA renewal applications.

**Immigration Center for Women & Children (ICWC):** At a \$100 consultation fee (services not guaranteed after consultation) ICWC offers fee based legal assistance for the following cases only; U visa, T visa, VAWA (Violence Against Women Act), naturalization, DACA, Deferred Action, parole cases, & EAD (work permit). Not currently taking any asylum or family based cases. Fees vary by case but are generally more affordable than a private attorney (0% interest payment plans offered), however homeless unaccompanied minors who entered the country without either parent receive services at no cost.
