AN ORDINANCE TO AMEND TITLE 2 OF THE CLARK COUNTY CODE BY AMENDING SECTION 2.68.060 – HEARING OFFICER COMPENSATION.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION ONE. Section 2.68.060 of the Clark County Code is hereby amended as follows:

2.68.060 – Hearing officer compensation.

The hearing officer, unless employed by the county shall be entitled to compensation from the county for services rendered on any given hearing at the rate of [seventy]one-hundred and twenty dollars per hour with a maximum chargeable time of ten hours per hearing. In the event that a hearing officer serves more than ten hours on any given hearing, he or she may submit to the board a written statement requesting additional compensation and setting forth reasons therefore. The board may authorize such additional compensation at the rate of [seventy] one-hundred and twenty dollars per hour if it is satisfied that the additional hours of service were justified and necessary.

SECTION TWO. If any provision, section, paragraph, sentence, clause, or phrase of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity of the remaining parts of this ordinance. It is the intent of the County Commission in adopting this ordinance that no portion or provision thereof shall become inoperative or fail by reason of any invalidity or unconstitutionality of any other portion or provision, and to this end all provisions of this ordinance are declared to be severable.

SECTION THREE. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION FOUR. This ordinance shall take effect and be in force_[beginning] 180 days] on January 1, 2025, after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
